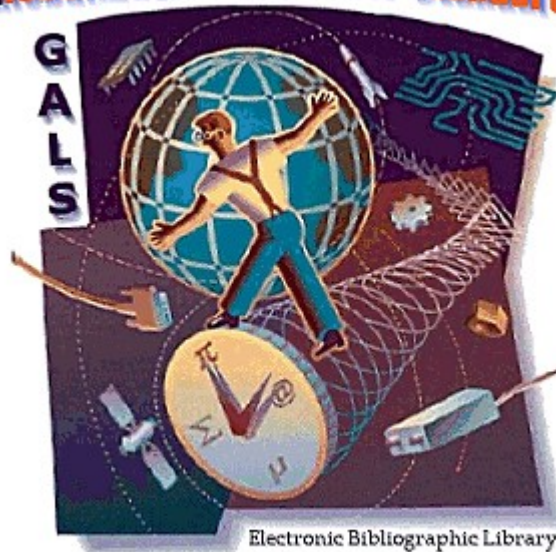

Book Review

Diamond, Stephen F. *From 'Che' to China: Labor and Authoritarianism in the New Global Economy* (Vandeplas Publishing, 2009)

Abstract:

From 'Che' to China: Labor and Authoritarianism in the New Global Economy argues that globalization is not a progressive force that is giving rise to a new democratic capitalism. In fact, authoritarianism, in part influenced by neo-stalinist regimes and their intellectual architects such as 'Che' Guevara, remains an

important political force and the new global capitalism itself is contributing to its persistence. In particular, the labor organization is now seen by authoritarian regimes as a source of power and control over the general population. To realize the democratic potential in the globalization process, a new autonomous labor movement responsible to its rank and file members must emerge. This requires an intellectual break with the consensus view that capitalism can safely accommodate healthy trade unions in a stable world order.

Labor Rights as Human Rights

Risse, Mathias, "A Right to Work? A Right to Leisure? Labor Rights as Human Rights", *Law & Ethics of Human Rights* v. 3 no1 (2009) p. 1-39

Abstract:

This article discusses whether or not specific labor rights, such as the right to work and right to leisure, can be viewed as enforceable human rights. The author discusses some criticisms of framing these as affirmative rights, including the concern that doing so would dilute more urgent human rights. The author considers various conceptions of human rights in order to discern which conceptions are most compatible with labor rights as human rights. First, the author argues that a human rights framework based on membership in the global political and economic order could strengthen some labor rights, because individuals' economic lives are influenced by global forces over which they may have little control. Second, the author considers a conception of labor rights based on equal ownership of Earth's resources, which would lead to inherent labor rights for all humans. The author concludes that even under these favorable conceptions, labor rights can protect the right to pursue work free from discrimination and the right to some limitations on working hours, but not provide the basis for an affirmative right to work or leisure.
